Our Construction Associate members include construction companies, design and engineering firms, equipment and material suppliers and firms which provide other services necessary to ensure safe, well managed, high-quality, cost-effective construction projects in the Owner/User facilities.

COCA, Inc. members are provided the opportunity to attend quarterly meetings, conferences, and safety training programs. They are also encouraged to participate in one or more COCA committees. COCA, Inc. yearly format consists of four quarterly lunch meetings lasting approximately two hours each. In addition, we hold training sessions in the spring and fall which consist of either an Osha 8 hour or 30 Hour (29CFR1910) General Industry Safety and Health Training; or an OSHA 10 Hour or 30 Hour (29CFR1926) Construction Safety & Health programs. We also hold a Trenching & Shoring Competent Person Training session mid-spring. These training sessions are offered on an “as needed” basis. Formal announcements regarding meetings, conference program topics, and training schedules are sent out a few weeks prior to each event.

COCA, Inc. quarterly meetings are only open to current members, however, all training sessions and any conferences that are held are open to anyone interested in attending. We encourage COCA, Inc. members to invite prospective clients to COCA, Inc. quarterly meetings to experience firsthand what COCA offers.

COCA, Inc. members have the opportunity to participate in COCA’s annual Golf and Trap event which held mid-June each year. This gives COCA, Inc. members the opportunity to network and solidify partnerships with their clients and guests while enjoying a fun day.
